AN AMENDMENT TO THE CODE OF ORDINANCES, CHAPTER 15, MOTOR VEHICLES AND TRAFFIC, SECTION 302,  
SCHEDULE 2(B).  
ORDINANCE 735**

**WHEREAS**, Borough Council has received a request to prohibit parking on the west side of N. Bergen Street from Delaware Avenue to School Street in order to allow for a patient drop-off/pick-up zone and;

**WHEREAS**, Borough Council has determined that such restrictions are reasonable and are needed to ensure the public safety of patients seeking vision care.

**NOW, THEREFORE, BE IT ORDAINED** as follows: Code of Ordinances, Chapter 15, Motor Vehicles and Traffic, Part 3, Section 302, Schedule 2(B), is hereby amended to prohibit parking on the following streets:

**SPECIAL PARKING ZONES ESTABLISHED; PARKING OTHERWISE PROHIBITED.** The following are hereby established as special purpose parking zones, and it shall be unlawful for any person to park any vehicle or tractor or to allow the same to remain parked, in any such zone, except as specifically provided for such zone: (Add the following signs)

Pick-Up and Drop-Off, No Parking Mondays-Fridays, 9:00 a.m. to 6:00 p.m. on N. Bergen Street, west side, from Delaware Avenue south the School Street.

**GENERAL REPEALER**

All Ordinances or parts of ordinances, inconsistent herewith shall be and are herewith repealed.

**SEVERABILITY**

The provisions of this Ordinance are severable. If any provision, sentence, clause, phrase, section or part thereof shall for any reason be found unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not effect or impair any of the remaining provisions, sentences, clauses, phrases, sections, or parts thereof, but the same shall remain in effect. It is hereby declared to be the intent of the Borough that this Ordinance shall stand notwithstanding the invalidity of any part included herein.

**EFFECTIVE DATE**

The provision of this Ordinance shall become effective 30 days from the date of passage of this Ordinance.
