

ORDINANCE NO. 767

**BOROUGH OF FOUNTAIN HILL  
LEHIGH COUNTY, PENNSYLVANIA**

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE BOROUGH OF FOUNTAIN HILL, CHAPTER 15, PART 3, PARKING VIOLATIONS, AMENDING SECTION 302 ( c ) (3), AND SCHEDULE 2, AMENDING (B) (7).

1. SECTION 302 ( c ) (3), shall be amended as follows:

(3) At any place where handicapped parking spaces have been designated. *The designated handicapped parking space is a maximum of twenty (20) feet (or less based on the property width) as measured starting from the handicapped sign post and moving in the direction away from the sign face.*

SCHEDULE 2, (B),(7), Special purpose parking signs are hereby erected at the following locations:

<u>Street</u>	<u>Location</u>	<u>Sign To Read</u>
S. Hoffert Street	On the Southwest side, beginning at a point 25 feet from Broadway and extending a distance of 70 feet	Patient Parking Only, Two (2) Hour Time Limit, Monday – Friday, 8:30 am to 6:00 pm.

2. **GENERAL REPEALER.** All Ordinances or parts of ordinances, and all resolutions or part of resolutions, inconsistent herewith shall be and are herewith repealed.

3. **SEVERABILITY.** It is hereby declared to be the legislative intent that if a court of competent jurisdiction declares any provisions of this Ordinance to be invalid or ineffective in whole or in part, the effect of such decision shall be limited to those provisions which are expressly stated in the decision to be invalid or ineffective, and all other provisions of this Ordinance shall continue to be separately and fully effective. Borough Council hereby declares that it would have passed this Ordinance and each section or part thereof, other than any part declared invalid, if it has advance knowledge that any part would be declared invalid.

4. **PROCEDURAL DEFECTS IN ENACTMENT.** Any procedural challenge shall be filed in accordance with applicable law.

5. **ENACTMENT.** Under Authority of Law, Borough Council of Fountain Hill hereby enacts and ordains into an Ordinance the attached documents this date of July 5, 2011. The provisions of this Ordinance shall become effective immediately from the date of passage of this Ordinance.
