RESOLUTIONS

BOROUGH OF FOUNTAIN HILL RESOLUTION NO. 2020- 25

A RESOLUTION OF THE BOROUGH COUNCIL OF THE BOROUGH OF FOUNTAIN HILL, LEHIGH COUNTY, PENNSYLVLANIA, TO INCREASE THE RATES OF SANITARY SEWER RENTALS IMPOSED UNDER CHAPTER 18 OF THE BOROUGH'S CODE OF ORDINANCES

WHEREAS, Chapter 18, Part 2, Section 203 of the Code of the Borough of Fountain Hill permits Borough Council to amend the rates of sanitary sewer rentals from time-to-time by resolution; and

WHEREAS, the Borough's sanitary sewer lines are undergoing a multi-year rehabilitation to reduce the inflow and infiltration of stormwater into the sanitary sewer system; and

WHEREAS, such rehabilitation necessitates an increase in the rates of sanitary sewer rentals, effective April 1, 2020, starting with the bills issued for the Second Quarter of Calendar Year 2020; and

WHEREAS, a regular meeting of Borough Council was held on April 6, 2020 for the purpose of reviewing a proposal to increase the rates of sanitary sewer rentals for the reason set forth above.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Fountain Hill to amend the rates of sanitary sewer rentals, pursuant to Chapter 18, Part 2, Section 203 of the Code of the Borough of Fountain Hill, effective as of April 1, 2020, starting with bills issued by the Borough for such rentals for the Second Quarter of Calendar Year 2020:

BOROUGH OF FOUNTAIN HILL RESOLUTION NO. 2020- 26

A RESOLUTION OF THE BOROUGH COUNCIL OF THE BOROUGH OF FOUNTAIN HILL, LEHIGH COUNTY, PENNSYLVLANIA, FINDING THAT A DISASTER HAS OCCURRED AS A RESULT OF THE TRANSMISSION OF A NOVEL **CORONAVIRUS** (COVID-19); AUTHORIZING THE MAYOR TO DECLARE A LOCAL DISASTER EMERGENCY IN THE BOROUGH PURSUANT TO SECTION 7501 OF THE PENNSYLVANIA EMERGENCY MANAGEMENT SERVICES CODE; CONSENTING AND RATIFYING THE CONTINUANCE OF THE EMERGENCY DECLARATION UNTIL JUNE 1, 2020, UNLESS SOONER TERMINATED BY ACTION OF BOROUGH COUNCIL: AND CONTINUING THE DUE DATE OF ANY SOLID WASTE COLLECTION AND DISPOSAL FEES AND SANITARY SEWER RENTALS TO JULY 15, 2020, AND FOR THE TAKING OF ALL RELATED ACTIONS

WHEREAS, the transmission of a novel coronavirus (COVID-19) has been recognized as a pandemic, and has caused or threatens to cause injury, damage and suffering to the persons and property of the Borough of Fountain Hill; and

WHEREAS, the aforesaid pandemic has endangered the health, safety and welfare of a substantial number of persons residing in the Borough of Fountain Hill, and threatens to create problems greater in scope than the Borough may be able to resolve; and

WHEREAS, on March 6, 2020, the Governor of Pennsylvania issued a proclamation of disaster emergency throughout the Commonwealth as a result of the transmission of COVID-19, which urged the governing bodies and executive officers of all political subdivisions affected by the emergency to act as necessary to meet the current exigencies as legally authorized under the Governor's proclamation; and

WHEREAS, Section 7501 of the Pennsylvania Emergency Management Services Code, as amended, 35 P.S. §7501, permits Borough Council to authorize the Mayor to declare the existence of a local disaster emergency; and

WHEREAS, the transmission of COVID-19, and its recognition as a pandemic, justifies a finding that it constitutes a local disaster emergency; and

WHEREAS, on or about March 20, 2020, the Mayor declared a local disaster emergency in the Borough, and the basis for the emergency declaration, the transmission of COVID-19, continues to exist and is anticipated to continue to exist until at least April 30, 2020; and

WHEREAS, Borough Council seeks to consent to and ratify the continuance of the local emergency declaration under Section 7501 of the Pennsylvania Emergency Management Services Code until April 30, 2020; and

WHEREAS, given the local disaster emergency declaration, the due dates for certain solid waste collection and disposal fees and sanitary sewer rentals should be extended.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Fountain Hill finds that a local disaster emergency exists in the Borough of Fountain Hill as a result of the transmission of COVID-19.

BE IT FURTHER RESOLVED by the Borough Council of the Borough of Fountain Hill to hereby authorize the Mayor to declare a local disaster emergency under Section 7501 of the Pennsylvania Emergency Management Services Code.

BE IT FURTHER RESOLVED by the Borough Council of the Borough of Fountain Hill to hereby ratify the aforesaid declaration made on March 20, 2020 and to approve its continuance until April 30, 2020, unless sooner terminated by action of Borough Council as allowed under the Pennsylvania Emergency Management Services Code.

BE IT FURTHER RESOLVED by the Borough Council of the Borough of Fountain Hill that should the due date or deadline for payment of any solid waste collection and disposal fees imposed under Chapter 20 of the Borough's Code of Ordinances occur during the period that the declaration of local disaster emergency is in effect, such due date or deadline for payment shall be continued to July 15, 2020, which shall become the effective due date or deadline for any such payments.

BE IT FURTHER RESOLVED by the Borough Council of the Borough of Fountain Hill that should the due date or deadline for payment of any sanitary sewer rentals imposed under Chapter 18 of the Borough's Code of Ordinances occur during the period that the declaration of local disaster emergency is in effect, such due date or deadline for payment shall be continued to July 15, 2020, which shall become the effective due date or deadline for any such payments.

Ms. Katrina Kepner of 634 S Lynn St offered her assistance and also mentioned initiatives already taken in her immediate neighborhood to help keep children engaged (e.g. chalk drawings).

B. Public Works (**Jordan**, Trotter, Rufe)

Ms. Jordan mentioned that Public Works employees work in different locations to adhere to "social distancing". Ms. Jordan suggested for anyone to purchase scarce resources, such as disinfectant wipes, if available and bring to the Borough for Public Work employees to use and be reimbursed for any expenses. Chief Bachert reported that one of the officers is out on leave due to potential COVID-19 cross contamination as recommended by St. Luke's hospital.

E. Fire (**Trabel,** Halleman, Rufe)

Ms. Halleman questioned what caused the oil spill on the Russell Ave that the Fire and Police Departments had responded to. Chief Bachert explained that some unauthorized construction work causing the spill was detected. The violations are reviewed and expected to be fined.

F. Recreation (**Johnson**, Rufe, Trabel)

Ms. Johnson is in discussion with the YMCA regarding the fixed fee pool management contract and any summer recreation program in light of the COVID-19 outbreak. She mentioned to potentially re-allocate the budgeted funds to the small business assistance program instead.

G. Health & Sanitation (Halleman, Johnson, Trabel)

Ms. Halleman read the February Sewer and Garbage collection reports.

Regarding the Refuse/Recycling RFP, Ms. Halleman recommended to retain the recycling option in the new contract. Mr. Branco reminded to review the RFP and respond to allow for 45 days of advertisement.
