#### **SECOND READING**

#### **ORDINANCE #846**

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE BOROUGH OF FOUNTAIN HILL, ESTABLISHING THE REAL ESTATE AND OTHER TAXATION FOR BOROUGH PURPOSES FOR FY 2019.

**SECTION I** - The Real Estate Tax Rate for all Borough purposes for Fiscal Year 2019 is as follows:

General Fund
8.63 mills (Municipal government operations)
Fire Department
0.08 mills (Debt payment on fire apparatus)
Library Services
0.40 mills (Provision of Library services)
Total
9.11 mills

These taxes are to be levied on all properties in the Borough subject to taxation for Borough purposes.

#### GENERAL REPEALER

All Ordinances or parts of ordinances, especially Ordinance #839, and all resolutions or part of resolutions, inconsistent herewith shall be and are herewith repealed.

#### **SEVERABILITY**

The provisions of this Ordinance are severable. If any provision, sentence, clause, phrase, section or part thereof shall for any reason be found unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not effect or impair any of the remaining provisions, sentences, clauses, phrases, sections, or parts thereof, but the same shall remain in effect. It is hereby declared to be the intent of the Borough that this Ordinance shall stand notwithstanding the invalidity of any part included herein.

#### EFFECTIVE DATE

The provision of this Ordinance shall become effective January 1, 2019.

#### **ORDINANCE NO. 847**

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE BOROUGH OF FOUNTAIN HILL, CHAPTER 18, SEWERS AND SEWAGE DISPOSAL, PART 2, RATES AND CHARGES, SECTION 210, COLLECTION OF SEWER RENTS, SUBSECTION B, PARAGRAPH 2, DELINQUENT RENTALS, SUBPARAGRAPH (d),

# MONTHLY PAYMENT PLANS, AMENDING CERTAIN PROVISIONS RELATING TO PAYMENT PLANS.

WHEREAS, the Borough of Fountain Hill wishes to amend Chapter 18, Part 2, Section 210, Subsection B, Paragraph 2, Subparagraph (d), of the Codified Ordinances of the Borough of Fountain Hill regarding payment plans associated with delinquent sewer rentals;

**WHEREAS**, the Borough of Fountain Hill wishes to allow payment plans for delinquent rentals equal to or greater than \$1,000.00, as more fully set forth in this Ordinance; and

**WHEREAS**, the Borough of Fountain Hill has determined that it is in its best interests of the residents of the Borough of Fountain Hill to adopt such an ordinance.

**NOW THEREFORE, BE IT DULY ENACTED** and **ORDAINED** by the Borough Council of the Borough of Fountain Hill:

Chapter 18, Part 2, Section 210, Subsection B, Paragraph 2, Subparagraph (d) of the Code of the Borough of Fountain Hill shall be amended in its entirety as follows:

- (d) The monthly payment plans shall be completed as follows:
  - (i) If the total amount of delinquent rentals is less than \$500.00, the property owner may enter into a repayment plan not to exceed ninety (90) days, with a minimum monthly payment equal to the total amount outstanding divided by three (3).
  - (ii) If the total amount of delinquent rentals is equal to or greater than \$500.00 but less than \$1,000.00, the property owner may enter into a repayment plan not to exceed one hundred twenty (120) days, with a minimum monthly payment equal to the total amount outstanding divided by four (4).
  - (iii) If the total amount of delinquent rentals is equal to or greater than \$1,000.00, the property owner may enter into a repayment plan not to exceed one hundred eighty (180) days, with a minimum monthly payment equal to the total amount outstanding divided by six (6).

#### **GENERAL REPEALER**

All ordinances or parts of ordinances, and all resolutions or parts of resolutions, inconsistent herewith shall be and are herewith repealed.

#### **SEVERABILITY**

The provisions of this Ordinance are severable. If any provision, sentence, clause, phrase, section or part thereof shall for any reason be found unconstitutional, illegal or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, phrases, sections, or parts thereof, but the same shall remain in effect. It is hereby declared to be the intent of the Borough of Fountain Hill that this Ordinance shall stand notwithstanding the invalidity of any part included herein.

#### **EFFECTIVE DATE**

The provisions of this Ordinance shall become effective in accordance with the Borough Code, 8 Pa.C.S.A. §3301.3, the date when the Mayor approves the Ordinance, or the date of enactment by the Council over the veto of the Mayor, or for an Ordinance not returned by the Mayor at the next scheduled meeting of council occurring at least ten days (10) after the meeting at which the Ordinance was enacted by the Council, the date of the succeeding scheduled meeting of Council.
