# PRIVILEGE OF THE FLOOR/ PRE-SCHEDULED

• 1336 Russell Ave Development

Attorney Erv McLain, representing 1336 Russell Ave Land Development, LLC, introduced Mr. Gabe Solms, Ashley Development Corporation and Mr. Sean Dooley, Keystone Consulting Engineers to present the current status of the 1336 Russell Ave Development plans to Council.

Mr. Solms referred to previous residential projects similar to the planned 1336 Russell Ave development. He identified potential customers ranging from young professionals to 55 and up folks. Mr. Solms delineated the history of this project from its purchase in 2019 to the subsequent reviews by the Zoning & Hearing Board and the Planning Commission.

Mr. Dooley continued to describe the site location and size. The property has access to public water, sewer, gas and storm sewer with two tanks draining to a system of pipes and eventually releasing storm water into a system of inlets. 18 apartments with 36 parking spaces are planned. The construction will increase the impervious area, as it relates to storm water, by only 4,000 sqft. The access road to the building is essentially a cul-de-sac – yet large enough for a fire ladder truck to go all the way around. The Fire Chief inquired if an additional fire hydrant would be installed. Mr. Dooley explained that only the existing fire hydrant would be replaced by a new one. The Police Chief, the Public Works Supervisor, and Hanover Engineering agreed, that after reviewing the plans they are satisfied with the plans at this stage.

Keystone Consulting Engineers requests on behalf of the developer to waive the requirement of a sub-street to serve no more than 25 dwelling units.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Fountain Hill, Lehigh County, Pennsylvania:

**THAT** a tax be and the same is hereby levied on all real properties within the Borough of Fountain Hill subject to taxation for the fiscal year 2022 as follows:

**SECTION 1.** Tax rate for general purposes, the sum of 9.13 mills on each dollar of assessed valuation, or the sum of \$0.913 on each one hundred dollars of assessed value.

**SECTION 2.** Tax rate for the Fire Department, the sum of 0.08 mills on each dollar of assessed valuation, or the sum of \$0.008 on each one hundred dollars of assessed value.

**SECTION 3.** Tax rate for Library Services, the sum of 0.40 mills on each dollar of assessed valuation, or the sum of \$0.040 on each one hundred dollars of assessed value
