President Rapp introduced Resolution 2017-17 explaining that Mr. Trabel believed the 2017 pool fees passed during the budget discussions were too low and needed to be raised further. President Rapp believes that raising the fees chases away business despite the rising costs of maintaining the pool. Mr. Blatt agreed that the pool was never meant to make profits, but as a service to the community. Ms. Halleman agreed that the fees passed at budget time were acceptable. At 7:05pm, Mr. Trabel arrived and explained that he researched other pool's rates and wished to raise daily rates another \$1 and raise season passes to \$75. President Rapp called for a motion to pass the 2017 Pool Rates as discussed and passed during the budget.

ORDINANCE NO. 833

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE BOROUGH OF FOUNTAIN HILL, CHAPTER 15, PART 3, PROHIBITING PARKING AT VARIOUS TIMES, AMENDING SECTION 302 (c) (3), BY APPROVING THE DELETION OF THE FOLLOWING HANDICAPPED PARKING SPACES

GENERAL REPEALER

All Ordinances or parts of ordinances, and all resolutions or part of resolutions, inconsistent herewith shall be and are herewith repealed.

3. **SEVERABILITY.** It is hereby declared to be the legislative intent that if a court of competent jurisdiction declares any provisions of this Ordinance to be invalid or ineffective in whole or in part, the effect of such decision shall be limited to those provisions which are expressly stated in the decision to be invalid or ineffective, and all other provisions of this Ordinance shall continue to be separately and fully effective. Borough Council hereby declares that it would have passed this Ordinance and each section or part thereof, other than any part declared invalid, if it has advance knowledge that any part would be declared invalid.

4. **PROCEDURAL DEFECTS IN ENACTMENT.** Any procedural challenge shall be filed in accordance with applicable law.

5. **ENACTMENT.** Under Authority of Law, Borough Council of Fountain Hill hereby enacts and ordains into an Ordinance the attached documents this date of February 6, 2017. The provisions of this Ordinance shall become effective immediately from the date of passage of this Ordinance.
