Since the votes for the election for Council President were tied between the two candidates, Mayor Gifford cast the decisive vote for Mr. Atkinson to be the newly elected Council President. Mr. Atkinson took the meeting over from Mr. Blatt.

PRIVILEGE OF THE FLOOR – Discussion on Agenda Items

Ms. Megan Martin, a Fountain Hill Borough resident on 1258 Broadway, presented the "Project Lifesaver" to Council and suggested to Council to become a member agency. Project Lifesaver is a 501 (C)(3) community based, public safety, non-profit organization that provides law enforcement, fire/rescue, and caregivers with a program designed to protect, and when necessary, quickly locate individuals with cognitive disorders who are prone to the life-threatening behavior of wandering. The program is run at a municipality level by public safety agencies, such as the local Police Department.

Mayor Gifford is simultaneously going to address the Police Department to get additional quotes on "Search and Rescue" technology equipment.

MAYOR'S REPORT

The Mayor expressed her deep sorrow for the passing of the late Council President, Larry Rapp. Ms. Gifford reported that she had read the Mayoral Proclamation to Larry Rapp honoring him for the many years of service to the Borough and its various organizations a few days before his passing. She thanked Council for their support to have Dodson Field renamed to the late Council President's name.

Mayor Gifford updated Council on the latest Police report.

Mayor Gifford announced a new initiative, "Fountain Hill Prowl", to get more residents involved in the efforts of the Small Business Alliance to help and promote local businesses.

• Title 8 of the Pennsylvania Assembly requires to fill a vacancy in an elective borough office (i.e. Council seat) within thirty (30) days after the vacancy happens, or if it fails to do so, fill the vacancy within fifteen (15) additional days by the vacancy board. The vacancy board shall consist of the council, exclusive of the mayor, and one registered elector of the borough who shall be appointed by the council at the council's first meeting each calendar year or as soon as practical and who shall act as chair of the vacancy board.

Mr. Branco presented a letter of interest from Jose Rosado to serve as Vacancy Chairman. The term will expire on 12/31/2019. (this is a yearly appointment).
