## BOROUGH OF FOUNTAIN HILL COUNCIL MEETING MINUTES July 6, 2020 7:00 PM

EXECUTIVE SESSION - An Executive Session was held starting at 6 PM to discuss personal matters regarding the Solicitor and Acting Chief. No action was taken and the Executive session ended at 6:55 PM

Due to the disturbance caused by unknown persons during the June 17, 2020 virtual Council meeting, this July 6, 2020 was held at Borough Hall for Council members only in order to adhere to COVID-19 CDC "social distancing" guidelines.

A meeting notice was placed on the Borough Website on July 2, 2020 informing the residents where to view the meeting as well as supplying a phone number and email address on which comments & questions could be addressed. The meeting was streamed live on *facebook.com/jamiefromfountainhill*. Again, residents had been invited to address questions via email (to the Borough Manager) beforehand or speak on agenda and non-agenda items via phone during the meeting. Due to phone issues, and alternate phone number was provided before and during the meeting for residents.

Council members present were: Ms. Jordan, Ms. Johnson, Mr. Rufe, Mr. Trotter, Mr. Atkinson, Mayor Gifford, and Mr. Trabel. Ms. Halleman refused to wear a facemask and left the meeting at 7:13. Also, in attendance were Anthony Branco (Borough Manager), Pete Lehr (Solicitor), Tom Wargo (Zoning Officer), Wayne Hochwarter (Acting Police Chief) and Jason Quarry (Public Works Supervisor).

At 7:15 PM, Council President Atkinson called the meeting to order and asked for everyone to rise for the Pledge to the Flag.

# PRIVILEGE OF THE FLOOR

Due to weather conditions, the Borough's telephone system was interrupted. An alternate Borough cell phone number was announced on the live *facebook* stream throughout the meeting.

- Ms. K. Keptner at 634 S Lynn Street called in the alternate phone number to verify connectivity.
- Mr. M. Spencer at 1035 Jeter Ave raised concerns that the July 6, 2020 Council meeting was not properly advertised and the Executive Session was not sufficiently detailed. He recommended to approve the internally circulated Social Media draft policy that he had a copy of and assisted in drafting.

Mr. Branco noted that all Council meetings are advertised at the beginning of the calendar year and this specific Council meeting was published on the Borough's website on July 2, 2020. The Solicitor pointed out that any resident can address Council and only Council can ask the Solicitor for legal advice. When asked by Council President Atkinson, Council did not seek legal advice from the Solicitor for this matter.

- Mr. J Pietkiewicz, former Playground staff member, inquired about opening the Playground.
- Ms. C. Bresslen at 661 Norway Place reported that her neighbor's property at 609 Norway Place is overgrown with grass, weeds and infested by rodents and ticks. She had contacted the Zoning Officer about it as well.

Mr. Wargo had cited the property owner and discussed with Public Works to schedule a time to clean up the property. The Solicitor added that a municipal lien could be filed to seek restitution, followed by initiating a Sheriff's sale of the property if financially feasible.

To address the resident's immediate complaint Public Works will be cleaning the property. In addition, Council suggested to involve Lehigh County Social Services to address the situation in a more permanent way. Historical information on fines and liens against the property will have to be compiled and further discussed at the next Council meeting.

Mr. Wargo asked for a motion allowing to hire an outside contractor to clean up the property because Public Works is currently short-staffed.
