Ms. Colleen Breslin of 611 Norway Place represented herself and her neighbors in presenting to Council health concerns regarding a property at 609 Norway Place. Ms. Breslin stated that the grass has not been cut by the property owner in approximately two years. The property is now overgrown into neighboring properties and is infested with rodents and ticks. Ms. Breslin is seeking the help of Council to have the property owner cited and the property cleaned up. Mr. Rohrbach, Code Enforcement Officer, stated that he has been citing the property owner every day

for approximately one week and has been to the house on two occasions to speak with the property owner to no avail. Mr. Pete Lehr, Esq., explained to Council that the Borough retains the right to enter the property and clean up any health violations, but would look further into the legal verbiage. Council President Rapp directed Mr. Quarry, Public Works Supervisor, to clean up the yard when directed by Mr. Lehr and to have police officers accompany them.
