Mr. Rolen asked Council for a formal hearing to appeal his termination and asked to be re-instated as a Deputy Fire Chief. Fire Chief Richmond upheld his decision to terminate Mr. Rolen.

Mr. Lehr (Solicitor) noted that the Fountain Hill Voluntary Fire Co. is a separate organization based on its January 19, 2011 Constitution and By-Laws, and the Borough has not exercised any oversight over it. A "formal appeal" is not offered.

Officer Fritzinger valued Mr. Rolen's contribution to the Fountain Hill Voluntary Fire Co.

Mr. Alfred Albrecht, President of the Fountain Hill Voluntary Fire Co., regrets Mr. Rolen's termination and would like to see him re-instated as a member.

Mr. Mike Spencer of 1035 Jeter Ave expresses that Council should apply Ordinance 348 exercise its oversight.

Council Member Trabel recommended that the Borough should not get involved in the Fire Co.'s personnel decisions.
