#### RESOLUTION NO. 2019-33

## A RESOLUTION OF THE FOUNTAIN HILL BOROUGH COUNCIL IN SUPPORT OF A CITIZENS COMMISSION FOR LEGISLATIVE AND CONGRESSIONAL REDISTRICTING

**WHEREAS**, the citizens of the Borough of Fountain Hill in Lehigh County, and the Commonwealth of Pennsylvania deserve a fair, fully transparent, impartial and depoliticized process of the decennial drawing of state legislature and congressional districts of near equal population; and

WHEREAS, legislative and congressional redistricting has at times resulted in gerrymandered districts that favor one political party over others; and

WHEREAS, such gerrymandering of legislative and congressional districts has worked at times to the detriment of our representative democracy; and

WHEREAS, the creation of a truly independent citizens redistricting commission devoid of political motivation or partisanship will: ensure a fair, transparent, and accurate legislative and congressional redistricting process that respects political subdivisions; prohibit districts from being drawn to favor or discriminate against a political party or candidate; require the use of impartial and sound methodology when setting district boundaries; require public input; and fully comply with the constitutional requirement that "no county, city, incorporated town, borough, township or ward" be divided "unless absolutely necessary," and

WHEREAS, legislation to amend the Pennsylvania Constitution to reform the decennial legislative and congressional redistricting process with the intent of using fairness and sound methodology in a non-partisan fashion is required to ensure these reforms.

**NOW, THEREFORE, BE IT RESOLVED** that the Fountain Hill Borough Council does hereby support legislative efforts to amend the Pennsylvania Constitution to assign the decennial task of both legislative and congressional redistricting to an independent citizens' redistricting commission; and

**BE IT FURTHER RESOLVED** that we call upon all those elected officials and party leaders in the Commonwealth of Pennsylvania who represent the citizens of the Borough of Fountain Hill to publicly announce their support of and commitment to work towards passage of such legislative efforts, and that a copy of this resolution be delivered to each of them.

#### **ORDINANCES**

At 7:30 pm Ms. Jordan made the motion to adjourn the regular Council meeting to commence the Public Hearing and Voting on Ordinance No. 853 to create a Stormwater Municipal Authority. Mr. Trabel seconded it and the motion passed unanimously.

### Public hearing and Vote

Mr. Lehr summarized the legal process for creating the Stormwater Municipal Authority.

Mr. Brian Ferencin asked how the areas that the fees will be based on are measured. Mr. Branco explained that the City of Allentown had created a geographic information system (GIS) map to provide GIS information on impervious areas. For example, the City of Allentown set a stormwater fee of \$20/500 sf. impervious area.

Mr. Zionelli asked to define "impervious area". Mr. Branco noted that impervious areas refer to land that is covered by features that cannot absorb water.

ORDINANCE NO. 853

AN ORDINANCE OF THE BOROUGH OF FOUNTAIN
HILL, LEHIGH COUNTY, PENNSYLVANIA, CREATING A
STORMWATER MUNICIPAL AUTHORITY FOR THE
PURPOSES OF MANAGING STORMWATER ISSUES
WITHIN THE BOROUGH

WHEREAS, the Borough of Fountain Hill finds that stormwater management is necessary to protect the general health, safety, and welfare of the residents of the Borough. Therefore, the Borough of Fountain Hill determines that it is in the best interest of the public to create a Municipal Authority for the purposes of managing stormwater systems within the Borough.

NOW THERFORE, BE IT DULY ENACTED and ORDAINED by the Borough Council of the Borough of Fountain Hill:

- 1. The Borough of Fountain Hill hereby signifies its intention and desire to organize an Authority under the Act of May 2, 1945, P.L. 382 and its amendments, and known as the "Municipality Authorities Act of 1945."
- 2. The President and Secretary of the Borough Council are hereby authorized and directed to execute, on behalf of the Borough of Fountain Hill, Articles of Incorporation for said Authority in substantially the following form:

## ARTICLES OF INCORPORATION

# TO THE SECRETARY OF THE COMMONWEALTH OF PENNSYLVANIA

In compliance with the requirements of the Act of May 2, 1945, P.L. 382 and its amendments known as the "Municipality Authorities Act of 1945" the Borough of Fountain Hill, a municipal corporation located in the County of Lehigh and Commonwealth of Pennsylvania, desiring to incorporate an Authority thereunder, does hereby certify:

- 1. The name of the Authority is Fountain Hill Stormwater Authority, its registered office being Borough Hall, Fountain Hill, Pennsylvania.
- 2. Said Authority is formed under the provisions of Act of May 2, 1945, P.L. 382 and its amendments, known as "Municipality Authorities Act of 1945".
- 3. No other Authority has been organized under the Municipality Authorities Act of 1945 or under the Act, approved the 29<sup>th</sup> day of June, 1935, P.L. 463, and none is in existence in or for the Borough of Fountain Hill, the incorporating municipality.
- 4. The name of the incorporating municipality is the Borough of Fountain Hill.

5. The names, addresses and terms of office of the first members of the Board of Authority to be formed hereby are as follows:

- 6. The project or projects to be undertaken by said Authority shall be projects permitted and authorized by the laws of the Commonwealth of Pennsylvania as the Borough of Fountain Hill may from time to time by Resolution or Ordinance specify.
- 7. A certified copy of the Ordinance of the Borough of Fountain Hill authorizing the creation of said Authority, together with proof of publication of Notice of Filing of these Articles of Incorporation, are each submitted herewith.
- 8. The existence of the Authority shall terminate fifty (50) years from the date of filing, unless extended by an amendment to these Articles of Incorporation

- 3. The President and Secretary of the Borough Council are further directed to cause a notice of the substances of this Party, including the substance of the above Articles of Incorporation and of the proposed filing of the above Articles of Incorporation to be published once in the Morning Call, a newspaper published and of general circulation in the County of Lehigh, and in the Lehigh Law Journal, as directed by the Municipalities Authorities Act of 1945 and its amendments.
- 4. The President and the Secretary of the Borough Council are directed to file the said Articles of Incorporation, together with the necessary proofs of publication, with the Secretary of the Commonwealth, and to do all other acts and things necessary or appropriate to effect the

incorporation of the "Fountain Hill Stormwater Municipal Authority," including the payment of any filing fees in connection therewith.

- 5. The initial project to the undertaken by the Authority shall be:
  - a. To manage the stormwater issues affecting the Borough.
  - b. This Borough requests the Authority to undertake and consummate the initial project specified in Section 5(a) with all reasonable dispatch and diligence.
  - c. This Section shall not be construed to preclude this Borough from specifying other projects, by future action of this Borough, which may be undertaken by the Authority.
  - d. Enactment of this Section is deemed necessary for the benefit of and preservation of the public health, peace, comfort and general welfare of citizens of this Borough and will increase the prosperity of citizens of this Borough.

#### GENERAL REPEALER

All ordinances or parts of ordinances, and all resolutions or parts of resolutions, inconsistent herewith shall be and are herewith repealed.

#### **SEVERABILITY**

The provisions of this Ordinance are severable. If any provision, sentence, clause, phrase, section or part thereof shall for any reason be found unconstitutional, illegal or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, phrases, sections, or parts thereof, but the same shall remain in effect. It is hereby declared to be the intent of the Borough of Fountain Hill that this Ordinance shall stand notwithstanding the invalidity of any part included herein.

#### **EFFECTIVE DATE**

The provisions of this Ordinance shall become effective in accordance with the Borough Code, 8 Pa.C.S.A. §3301.3, the date when the Mayor approves the Ordinance, or the date of enactment by the Council over the veto of the Mayor, or for an Ordinance not returned by the Mayor at the next scheduled meeting of council occurring at least ten days (10) after the meeting at which the Ordinance was enacted by the Council, the date of the succeeding scheduled meeting of Council.

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE BOROUGH OF FOUNTAIN HILL, CHAPTER 15, PART 3, SECTION 302 (c)(3), TO ADD CERTAIN HANDICAPPED PARKING SPACES

BE IT ORDAINED by the Borough Council of the Borough of Fountain Hill, Lehigh County, Commonwealth of Pennsylvania, that Chapter 15, Part 3, Section 302(c)(3), shall be amended as follows:

- 2. **GENERAL REPEALER**. All Ordinances or parts of ordinances, and all resolutions or part of resolutions, inconsistent herewith shall be and are herewith repealed.
- 3. **SEVERABILITY**. It is hereby declared to be the legislative intent that if a court of competent jurisdiction declares any provisions of this Ordinance to be invalid or

ineffective in whole or in part, the effect of such decision shall be limited to those provisions which are expressly stated in the decision to be invalid or ineffective, and all other provisions of this Ordinance shall continue to be separately and fully effective. Borough Council hereby declares that it would have passed this Ordinance and each section or part thereof, other than any part declared invalid, if it has advance knowledge that any part would be declared invalid.

- 4. **PROCEDURAL DEFECTS IN ENACTMENT**. Any procedural challenge shall be filed in accordance with applicable law.
- 5. **ENACTMENT**. Under Authority of Law, Borough Council of Fountain Hill hereby enacts and ordains into an Ordinance the attached documents this date of February 20, 2019. The provisions of this Ordinance shall become effective immediately from the date of passage of this Ordinance.
