# PROPERTY OWNER'S SEWER LATERAL VIDEO INSPECTION APPLICATION AND REPORT

This form must be completed by a Master Plumber or Industry Professional conducting the sewer lateral video inspection. This form must be submitted in conjunction with a copy of the video and proof of licensure. This report will assist the Borough Engineer in determining whether or not the sewer lateral is in compliance with the regulations set forth by the Borough's Ordinance # 861 (Sewer Lateral Ordinance). If the video does not meet the requirements listed below, the Borough may reject the video and request a resubmission. All testing shall be performed by a licensed professional at the property owner's expense.

The property owner shall make all repairs necessary to bring the Building Sewer or Sewer Lateral into compliance with the Ordinance, or replace the Building Sewer or Sewer Lateral in accordance with all Borough requirements. All costs of repair or replacement of the Building Sewer or Sewer Lateral shall be borne by the Property Owner.

### Sewer Lateral Video Requirements:

Must provide clear imagery

Display property address included on video

Display running foot or time marker on video

- Display date and timestamp on video
- Clearly display cleanout or access point
- > Briefly stop at joints to display integrity
- Identify where building drain ends and sewer lateral begins
- > Attach sketch plan to this form depicting sewer main, street, building, lateral location and trees within 20 feet.
- Submit lateral inspection from structure to main connection on a USB flash drive, in MP4 or WMV format.
- > If roots obstruct camera travel, provide video of both before and after root cutting/removal.
