ENGINEER’S REPORT

Ms. Smith (Hanover Engineering) presented storm sewer projects for 2022:

- Stormwater Inlets need to be replaced. She reported that forty of the total number of inlets (sixty or eighty) have already bags. She cautioned that only half of the sediment captured in the bags counts for pollution reduction. The replacement of a stormwater inlet costs about \$5,000.
- Broadway Curb & Sidewalk Storm Sewer Improvements
 In conjunction with the MTF Grant 2019 for the Broadway Curb and Sidewalk replacement simultaneous storm sewer improvements as outlined in detail in the “Broadway_StormSewerReplacementPlan” for an estimated cost of \$90,804.
- Hoffert St Storm Sewer Extension for an estimated cost of \$46,687.50.

- Stanley Ave Grass Alley Conversion
Storm Sewer improvements in conjunction with the Grass Alley Conversion in the amount of \$34,700.

Ms. Morrison asked for a motion to approve/add these projects to the Budget 2022.
