GENERAL REPEALER

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE BOROUGH OF FOUNTAIN HILL, CHAPTER 15, PART 3, SCHEDULE 1, PROHIBITING PARKING AT ALL TIMES IN CERTAIN LOCATIONS

BE IT ORDAINED by the Borough Council of the Borough of Fountain Hill, Lehigh County, Commonwealth of Pennsylvania, that Chapter 15, Part 3, Schedule 1 shall be amended as follows:

1. Schedule 1, Parking Prohibited at All Times in Certain Locations, shall be amended as follows:

ADD:

STREET	SIDE	BETWEEN
Delaware Avenue	South	90 feet east and 90 feet west of the intersection with North Bergen Street.
Delaware Avenue	North	90 feet east and 90 feet west of the intersection with North Bergen Street.
Delaware Avenue	South	90 feet east and 90 feet west of the intersection with North Lynn Street.

Delaware Avenue North 90 feet east and 90 feet west of the intersection with
North Lynn Street.
