### **ACCEPTED**

Leaves - loose or in bags (brown paper only)  
Small brush - up to 4" diameter (no longer than 6')  
Hedge trimmings, garden plants residue  
Christmas trees (free of ornaments, tinsel & plastic bags)

### **NOT ACCEPTED**

sod, soil, mulch, corn stalks  
tree stumps, root balls  
hay, straw, grass clipping  
bamboo, ornamental grass, pumpkins

**NOTE: YOU MUST BE A RESIDENT OF THE CITY OF BETHLEHEM, HANOVER TOWNSHIP (NORTHAMPTON COUNTY) OR FOUNTAIN HILL TO DROP OFF YARD WASTE. RESIDENTS WILL BE REQUIRED TO SHOW THEIR COMPOST CARD AND A VALID PA DRIVER'S LICENSE EACH TIME THEY VISIT THE YARDWASTE FACILITY. NO EXCEPTIONS WILL BE MADE.**

- Do not leave materials outside the fence.
- Plastic bags used to transport materials must be taken home.

**COMPOST/MULCH:** Compost/Mulch, as available, to City of Bethlehem, Fountain Hill and Hanover Township (Northampton Co.) residents inside the facility during normal business hours only.

**LOADING SERVICES:** Compost/Mulch loaded for \$10 per cubic yard. Loading services end at 2:45 p.m. each day. Pick-up trucks can no longer be self-loaded. We have a 3/30 gallon per visit limit of how much mulch/compost that can be self-loaded.

## **BETHLEHEM YARDWASTE FACILITY**

### **AS PER "PA VEHICLE CODE 75, CHAPTER 49, and PARAGRAPH 4903":**

All material must be tarped inbound and outbound from the yardwaste facility. If you have no tarp, you will be turned away from the facility.

If you are a Bethlehem resident, you must sign up for your compost card at the yard waste facility or City Hall – Recycling Office, Room 502B.

Hanover Township (Northampton County) residents must apply for a compost card at their municipal building.

Fountain Hill residents must apply for a compost card at their municipal building.

If you are an owner of property in the City of Bethlehem with 4 or less units, you must apply for a compost card at the Recycling Office in City Hall. Please bring proof of ownership (tax bill, water bill). The person the card is issued to will be required to be present for the card to be used.

For the safety of all of our customers, employees and your beloved animals, pets are not permitted inside the yard waste facility.
